ENROLLMENT PROCEDURE / CHECKLIST

STEP ONE – INITIAL APPLICATION

The following completed items should be forwarded to the registrar's office:

1. Family Information
2. Student Application
3. Application Fee of \$150 per family and testing fee of \$25 per child (for K-8th grades)
4. Written testimony from at least one parent briefly sharing how he/she came to know the Lord as his/her personal savior
5. Immunization Record
6. Copy of Birth Certificate
7. Copy of Social Security Card
8. Copy of Transcript and/or Report Card from last school year completed, Current Report Card and Standardized Test Results
9. If your child has any special learning issues/needs, please provide a copy of all reports and testing
10. Release of Records Form signed by parent

STEP TWO – REFERENCES

The following reference forms should be returned to us by the individuals who have completed them:

1. Personal Reference Form – to be completed by a friend of your family
2. School Reference Form – to be completed by the child's previous teacher (for K – 12th grade)
3. Church Reference Form – to be completed by the family's pastor or priest

STEP THREE – RECORDS REVIEW AND TESTING

The administration will review the school records that you have provided (step one, # 8 above). For students entering kindergarten through 8th grade, placement testing will be scheduled. Incoming kindergarten students will be given a kindergarten readiness test; 1st through 8th graders take both a math and a reading test. 9th through 12th grade students may be asked to take a math and/or a writing test if the administration deems it to be necessary.

STEP FOUR – MEETING AND ACCEPTANCE

The final application step is a meeting between the new family and the principal. If your child is entering grade PK – 5th, the parents will be meeting with the lower school principal. If your child is entering 6th-12th grade, you and your child will meet with the upper school principal. The purpose of the meeting is to further familiarize you with Salisbury Christian School, to discuss with you the meaning of Christian education and to finalize the placement of your child at SCS. After this meeting, you will receive notification of the acceptance of your child to SCS by the registrar either in writing or by a phone call.

SCS ADMISSION POLICIES

Salisbury Christian School admits students of any race, color, sex, and national and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the school and in the administration of its educational policies, admission policies, and school-administered programs. Salisbury Christian does not discriminate on the basis of race, color, sex and national and ethnic origin in the recruitment of faculty and staff.

Attendance at SCS is a privilege and not a right. Each student should value positive attitudes toward spiritual things and the school. Additionally, each student should recognize the positive culture of the school as important for his/her own personal welfare as well as the welfare of classmates... "Live peaceably with all men." Romans 12:18. Students are asked to seek a spirit of humility, willingness to learn, obedience, self-discipline, kindness and love.

REQUIREMENTS FOR ADMISSION

Salisbury Christian School desires to be a professional educational resource for Christian families in this region. Therefore, the following admission requirements have been established:

- At least one parent has a personal relationship with Jesus Christ as evidenced through a written testimony and attends church regularly.
- Willingness and desire to follow Jesus.
- Willingness and desire by student to attend SCS.
- Completed application forms, signed by parent(s), including health records (current health inventory, shot record, lead screening for students under age six), references and registration/testing fees.
- Satisfactory scholastic and behavioral records from previous school.
- Satisfactory performance on a placement test administered by SCS teachers.
- Personal interview for parents and students by the Administration
- It is expected that pre-kindergarten students already be toilet trained. The students should be able to use the bathroom independently. Occasional accidents are understandable, but a regular pattern of this will be unacceptable. "Pull-ups" are not permitted. If a student demonstrates a regular pattern of accidents, there will be a trial period of four weeks from the start date of the child in which to resolve this issue. If the child is not fully trained at the end of the four week period, the student will be withdrawn from SCS. When the child is trained, the parents may contact the registrar to inquire about openings; if an opening still exists, the child may return to SCS pending approval of the administration.

POLICIES FOR ADMISSION

1. Applications for admission of new students will be received at any time during the year. The appropriate registration fee must be included with the application.
2. Kindergarten – 12th grade homeroom class size is 24 students. Pre-K classes are limited to 18 students due to Maryland State Department of Education (Office of Child Care) regulations.
3. Acceptance is based on: space availability, academic and social readiness, siblings currently enrolled in SCS, Christian commitment, local church involvement, and recommendations from a pastor/priest, family friend and previous teacher (if applicable).
4. Eligible students will be accepted in the following order:
 - Staff member's children
 - Siblings of students already enrolled
 - New students / families
5. New students will be eligible for admission onto our waiting list after the requirements for admission have been completed. SCS will endeavor to admit an entire family at the earliest possible time.
6. Since specialists are needed to properly minister to children with special needs, and since we are unable to provide programs for them, we are unable to accept children: a) who have severe physical handicaps, b) who have severe learning or social difficulties, c) who are emotionally disturbed, and/or, d) who have a history of unruly or disruptive behavior.

RETURNING ADMISSION POLICY

If a family chooses to transfer their child/children from Salisbury Christian School to another school and then desires to return to SCS, the following requirements for re-admission are:

1. If a family has not been registered with SCS for one school year or less, please provide the following when requesting re-entry: Re-enrollment form and release of student records form(s). The parents will be asked to come for a meeting with the principal.
2. If a family has not been registered with SCS for more than one school year, the family will be asked to repeat the entire application process.

AGE OF ELIGIBILITY

One of the factors used to determine eligibility for students entering pre-kindergarten, kindergarten, and first grade is the birth date of the child. Please refer to the following chart for the appropriate birth date deadline for your child. These dates are consistent with guidelines established by the state of Maryland. Our experience has shown that children in these age groups are generally more successful academically and socially when these guidelines are followed.

HOME-SCHOOL ENROLLMENT POLICY

SCS offers partial enrollment to home-school students desiring specific courses. The purpose of this service is to aid home-school parents in the education of their children. The application process is the same as fully enrolled students with the following exception: SCS will not guarantee admittance into any course before August 15th of the school year in which the course is requested. The fee per course is 1/5 of the tuition. For a home-school student to participate in extra-curricular activities, the student must be enrolled in four courses. The re-enrollment fee is waived for home-school families who are enrolled in consecutive years.

In addition to the total credit hours, the following are requirements to graduate from Salisbury Christian School:

- Missionary / Community Service: 90 hours of unpaid service in a pre-approved program beginning after 7th grade.
- Required reading from book list with accompanying reports (quantity based on term of entry to SCS).
- Senior Essay

EXTENDED CARE

BEFORE SCHOOL CARE

For an additional cost, pre-kindergarten through 5th grade students may come to the before-school program beginning at 7:15 am. We ask that you register and pay in advance for this service. 6th-12th grade students may come to school beginning at 7:20 am for no additional charge. The students report to the multi-purpose room.

AFTER SCHOOL CARE

For an additional cost, pre-kindergarten through 12th grade students may join the after-school program from the end of the school day until 5:30 pm. Please register and pay in advance. A snack will be provided. The afternoon consists of homework time and age appropriate supervised activities.

FINANCIAL INFORMATION

TUITION PHILOSOPHY

The Board of Governors prayerfully sets tuition annually using historical data, realistic projections and other relevant factors. As a non-profit organization, our goal is to balance the budget and fully fund an excellent academic program at the lowest possible cost and to be consistent with biblical concepts of good stewardship and responsibility to students, parents, staff and administration.

APPLICATION FEE

An application fee of \$150 per family is due at the time your application is submitted to SCS. The application fee is nonrefundable if you withdraw your application or if your child is offered admission but you choose not to send him or her to SCS. The application fee will be refunded to you if SCS is not able to admit your child. If you prefer that SCS retain the application fee and apply it toward enrollment the following school year, please speak to the registrar. The fee you paid will be good for one school year.

TRANSFERRING FROM ANOTHER PRIVATE SCHOOL/DAY CARE

If your child is coming to SCS from another private school or day care, SCS may call the previous school to check your payment history. If you have outstanding debt at that school, SCS will place your application on hold until that debt is fully paid. If your payment history shows that your monthly bill was paid late on numerous occasions, SCS may ask you to meet with the business manager before acceptance of your children.

RELEASE OF STUDENT RECORDS

No student records will be released to any institution or person without a subpoena unless the student's tuition and fees are paid and up-to-date at the time of the request. If the responsible parties are unable to pay the full amount of the bill and desire a release of the student's records, then all responsible parties will be required to sign a promissory note for the amount due. No records will be released without full payment or a promissory note signed by all responsible parties.

TESTING FEE

For students entering kindergarten through 8th grade, a testing fee of \$25 per child is due at the time the application is submitted to SCS. If testing does not occur, the testing fee will be refunded to you. If testing does occur and your child does not attend SCS, the testing fee is non-refundable. The testing fee for incoming 9th through 12th graders should be paid at the time of the testing.

TUITION PAYMENT OPTIONS

At the time of acceptance to SCS, you will be asked to choose one of the following options for tuition payments:

1. Pay in full on June 1st. A 1% tuition discount applies if you choose this option. If you desire this option but you applied to SCS after June 1st, the 1% discount still applies. The full payment should be made at the time your first monthly payment is due.
2. Pay in 12 equal payments due on or before the first day of every month from June through May. The first two payments are non-refundable. Also please note: A finance charge of \$25 will be applied to your account for any monthly payment received after the 10th day of the month it is due. There will be a \$25 charge for returned checks.

FACILITIES MAINTENANCE FEE

A yearly \$100 facilities maintenance fee is billed to every family in July. This fee is non-refundable.

ATHLETIC FEE

An athletic fee will be charged to your account for each student in your family that participates in extra-curricular athletics. The fee is \$60 per student per sport for varsity teams; \$40 per student per sport for junior varsity and middle school teams.

FINANCIAL ASSISTANCE

SCS offers financial assistance on a limited basis to students in kindergarten through twelfth grade. The amount of financial assistance provided is based on the need of the applicants. For currently enrolled families, financial aid applications can be picked up in the business office beginning Feb. 1st each year. The application should be completed entirely and mailed before April 15th. Notification of amount awarded will be made before June 1st.

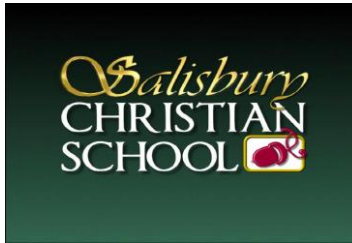
The Teacher

THE SCHOOL

SCS is a thoroughly Christian, interdenominational school serving students from pre-kindergarten (age 3) through grade 12. SCS is fully accredited through MSA (Middle States Association of Colleges and Schools) and ACSI (Association of Christian Schools International). Current enrollment is 582 students. The mission of SCS is to honor Jesus Christ by offering a comprehensive educational program founded upon Biblical truth and academic excellence. The vision of SCS is to lead students to spiritual, intellectual, social and physical maturity, in partnership with parents and the church, so that students become disciples of Jesus Christ, walking in wisdom, obeying His Word and living their faith.

FACULTY AND SUPPORT STAFF

The teaching staff consists of 52 teachers and 14 teaching assistants. The remaining 37 staff members are in administrative and support roles.

ADMISSIONS Registrar: Mrs. Daryl Ann Hudson

SCS seeks students who desire a Christian education, have satisfactory scholastic and behavioral records from previous schools and perform satisfactorily on an entrance test.

ACADEMIC PROFILE

SCS students consistently score above the national average on standardized achievement tests. Students in grades K-8 take the Stanford Achievement Test yearly. All high school students take the EXPLORE, PSAT and ASVAB. On the SAT, our seniors have scored from the average range (1000) to as high as 1560 (Math and English portions). Students are also encouraged to take the ACT. All juniors are required to take a college and career research course which has a concentrated focus on SAT preparation.

Membership in the SCS Chapter of the National Honor Society and the National Junior Honor Society is available for qualified students.

SCS has had one National Merit Scholarship finalist, two semi-finalists and four commended students. SCS has also had one University of Maryland Board of Regents Scholar and numerous AP Scholar Awardees and Distinguished Scholar semi-finalists.

GRADUATION REQUIREMENTS

Students must earn twenty-five credits, complete ninety hours of community/missionary service, and complete a senior essay or writing project. In addition, for each year of enrollment between 8th and 12th grades, students are required to read and report on three books per year, one of which is chosen by the English Department. The students may choose two of the books from the SCS recommended reading list.

Credit Requirements: Bible (3), English (4), Social Studies (3), Science (3), Math (3), Physical Education (1), Health (1/2), Fine Arts (1), College/Career Research (1/2), Computer Technology (2) and Electives (4). The college preparatory curriculum recommends 2-3 credits in a foreign language and requires Algebra 1, Algebra 2, and Geometry.

ADVANCED PLACEMENT COURSES

The following advanced placement courses are currently available: Literature/Composition, Language/Composition, US History, Psychology, Government, Biology, Computer, Calculus and Art History.

DUAL ENROLLMENT

Dual enrollment courses are available in cooperation with Wor Wic Community College. World Civilizations I and II are available on the SCS campus. Other courses may be taken by qualifying students at the campus of WWCC as scheduling permits.

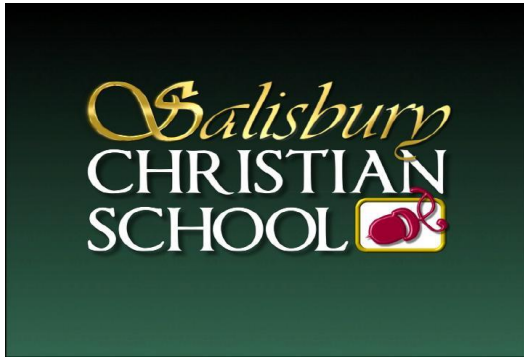

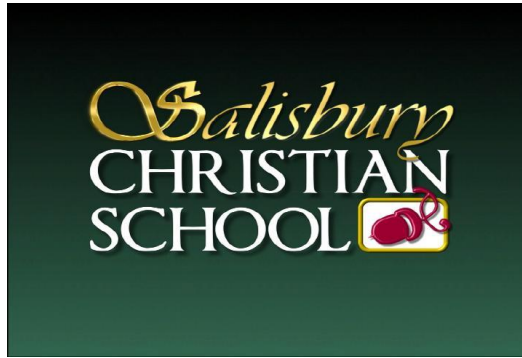

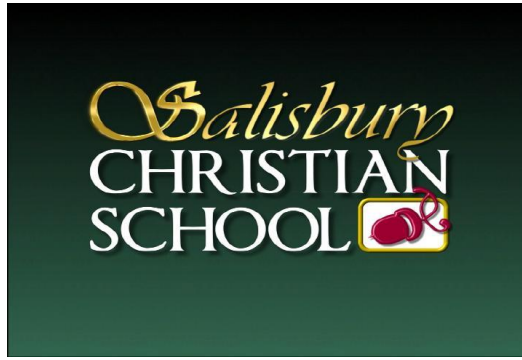
